She has been recognized by many clients for helping them win a lot of important invalidation and litigation cases, including CIMC, LG Electronics, Delta Electronics, ZTE, and Dajiang. For example, in 2019, she represented HKC who was accused of patent infringement in a series of patent infringement lawsuits concerning "LCD panel" and helped the client won the series of lawsuits, and in 2018, she represented the patentee, Jiangsu New Century, won a significant administrative lawsuit before the appeal court by revoking an invalidation decision on a key patent. She was awarded "Three-star Patent Attorney" by the China Intellectual Property News in 2017 and was awarded "Outstanding Patent Attorney" by the Beijing Patent Attorneys Association in 2018.
